### Fund Notes:

- General Fund - \$6,232: Membership dues totaled \$300 offset by \$53 phone bill. KS Grant balance \$6,012 vs General balance \$221.
- Construction Fund - \$148: Paid two Miller-Stauch invoice applications totaling \$235,456. The \$24,705 rollforward balance was released and we received UMB funding totaling \$210,751. The \$148 insurance claim payment will offset next application.
- Building Fund - \$14,817: Parent's night receipts totaled \$7,400 offset by \$3,890 in expenses, \$460 in calendar receipts, Fiesta Filipina's \$3,150 receipts offset by \$1,420 in related expenses, May Utilities (gas, electric, water) higher due to increased electricity usage, lawn mowings totaled \$525, terracon engineering expenses related to FCC expansion totaled \$3,422, paid \$1,045 pest extermination bill, and the Overland Park Food Service License renewal cost \$100.
- Cultural Arts Fund - \$13,594: March & April dues totaled \$283 offset by Sampaguita choir shirts expense of \$315.

#### Additional Notes:

- The rollforward Construction balance of \$24,705 was spent on May construction payments, prompting UMB to commence loan funding of our construction account. At the end of May, we received a UMB bill for interest payable on loan amount.
- State of KS annual report due 6/15/11 is completed listing this year's Executive Officers and Board of Directors. State of MO annual report is due 8/31/11.
- State of MO sales and use tax on purchases and sales has been renewed effective 5/25/11 through 5/25/14.
- Updating to electronic payment of all utilities to save money & time.
- Note cash balances within each fund account.
